INTRODUCTION

Management Group Investors, LLC, and its subsidiaries, Airport Shoppes, Corp., Airport Aviation Services, Inc., Carolina Catering Corporation, and Cargo Service Corporation ("we", "us" or "our") are committed to protecting your privacy. This statement describes the information we collect, our use of the same, and your options regarding our use of it. This statement also presents the steps we take to protect and how you can review and correct your personal information. This privacy statement refers to personal information that can be associated with a specific person and used to identify that person. Personal information does not include information that has been de-identified so that it does not identify a specific user, which may be used for any legal purpose.

YOUR CONSENT TO THIS PRIVACY STATEMENT

By accessing or otherwise using our Site or Services, you are consenting to the information collection and use practices described in this privacy statement. If you are using the Site or Services on behalf of a company or other legal entity, you hereby represent and warrant that you have the authority to consent to this privacy statement (and the Terms of Service applicable to the Site and Services) on behalf of the company or other legal entity. To the extent this privacy statement conflicts with any existing agreement between the company or other legal entity you represent and any of our affiliates, this privacy statement shall control and supersede such other terms and conditions with regard to the subject matter of this privacy statement. Additionally, if you are using the Site or Services on behalf of a company or other legal entity, you are nevertheless individually bound by this privacy statement even if your company has a separate agreement with us. As used in this privacy statement, "you" and "your" refer to you individually and the company on behalf of which you are entering into this privacy statement.

WHAT KINDS OF INFORMATION DO WE COLLECT?

Depending on how you use the Site, we may collect different kinds of information from or about you:

- **Information you provide:** We collect the content and information you provide when you use the Site, request information or assistance from us, when you post a review or comment of our services or products.
- Your content and information may include "**Personal Information**", which is any information that can be used to identify for you. For example, Personal information can include your:
 - o Contact information (name, address, phone number, or email address);
 - Photo or images;
 - Certain data about your use of the Site that is considered Personal Information in some jurisdictions; and
- User comments that you may provide, such as in reviews, testimonials, or comments. Please
 note that the information you submit in these user comments may be posted publicly on the Site.

- Payment Information: If you place an order, we will collect the information that we need to
 process your transaction, such as your name, billing address, shipping address, phone number,
 and the recipient's information if the order is a gift. We have engaged the following companies to
 help us process your payment card information securely: Evertec and MultiService. We do not

store any of your financial or credit card information, and the processing companies we use are required to be compliant with the Payment Card Industry Data Security Standard (PCI-DSS).

- Employment Application Information: If you apply for employment with us, we will collect your name, work history, and other information relevant to your employment application. We will not use your information for purposes other than evaluating and processing your employment application. We have engaged a company called HRSense to help us process your employment information securely.
- Information collected automatically: We collect information about your visit to our sites, including what pages you view, the number of bytes transferred, the links you click, the materials you access, and other actions taken within our sites. On sites that you enter with a user ID, we may connect this information with your identity to determine your potential interests in our products and services. We also collect certain standard information that your browser sends to every website you visit, such as your Internet Protocol (IP) address, your browser type and capabilities and language, your operating system, the date and time you access the Site or Services, and the website from which you linked to our Site or Services. The information we collect automatically is statistical data and may or may not include personal information, but we may maintain it or associate it with personal information we collect in other ways or receive from third parties. It helps us to improve and to deliver better and more personalized Services, including by enabling us to:
 - Estimate of our audience size and usage patterns.
 - Store information about your preferences, allowing us to customize our Site and Services according to your individual interests.
 - Speed up your searches.
 - Recognize you when you return to our Site or Services.
- Information we may collect from other sources. We may also collect information about you from third parties, including but not limited to third-party verification services, credit bureaus, mailing list providers, and publicly available sources.

HOW DO WE USE THIS INFORMATION?

We reserve the right to use the personal information we collect to deliver services or carry out transactions you have requested, such as providing information on our products and services, processing orders, handling service issues, answering customer service requests, and facilitating the use of our Site or Services, and so forth help provide and support our Sites. We may also use your information to communicate with you and deliver advertising that may be more relevant to you. We will obtain your consent to use your Personal Information for a purpose other than as described in this Privacy Policy and below:

• Offering, improving and developing the Site: We use your information to provide and improve the services that we offer, including to operate, maintain and develop Site content, features, and products. We also use your information to analyze our operations and marketing initiatives and develop new services and products in response to your feedback

- Communicate with you: We may use your information to send you information about your account, our services and products, marketing communications, and important administrative announcements about the Site or your Account. We also use your information to respond to you when you contact us.
- **Promoting Safety and Security:** We use the information we collect to help verify your identity, your account, and your activity on the Site. We might use this information, for instance, to investigate suspicious activity or violations of our Terms of Use or policies.

We use cookies and other data collection technologies to provide and support the Site and the uses outlined and described in this section of the Privacy Policy. HOW IS THIS INFORMATION SHARED?

We will only share your Personal Information we disclosed to you at the time we collect it, with your consent, or as stated below:

- With our service providers: We work with vendors that help us provide you the Site and related services. Unless prohibited by applicable law, we may share information with our vendors for purposes such as website hosting, professional services, human resources management, processing transactions, advertising, customer service, e-mail delivery, auditing and analyzing our Site and Services. When we share Personal Information with vendors, we provide them with only those elements of your personal information they need to deliver those services and require those vendors to process your Personal Information only on our behalf and for the same purposes for which the Personal Information was collected.
- With affiliates: We may share Information within our corporate family for the purposes described in this Privacy Policy and as required or authorized by law. Affiliates are those companies that are under common control of Airport Shoppes, which is the primary data controller for these purposes.
- As part of individual transactions: In connection with certain transactions, we may disclose some or all of your personal information to financial institutions, government entities, and shipping companies or postal services involved in fulfillment of orders.
- As part of a corporation transaction: Unless prohibited by applicable law, we may share, transfer or delete your Personal Information if we are involved in a merger, sale, acquisition, divestiture, restructuring, reorganization, dissolution, bankruptcy or other change of ownership or control by Airport Shoppes or any affiliated company (in each case, whether in whole or in part). If required by applicable law, any such sharing of information will be reported to regulators in accordance with the applicable law.
- In other lawful ways: We may also share your Personal Information: (i) if we determine that disclosure is necessary to comply with the request of a law enforcement, regulatory agency or other legal process; (ii) to protect the rights, privacy, property, interests or safety of our company or our affiliates, customers, business partners, suppliers, employees or the general public; (iii) to pursue available remedies or limit damages; (iv) to enforce our Terms of Use; (v) to respond to an emergency; and (vi) as otherwise permitted by applicable law.
- We will not share your personal information to the following with third party publishers, advertisers or developers.

COOKIES AND OTHER DATA COLLECTION TECHNOLOGY

We use cookies and other data collection technologies to help us provide, protect and improve the Site.

Cookies are small pieces of text used to store information on web browsers. Cookies are used to store and receive identifiers on computers, phones and other devices and they may contain information such as user settings, browsing history and other Internet activities. While the cookies that we use may change from time to time as we improve and update the Site, the types of cookies we use generally fall into the below categories:

- Session Cookies are used to operate our Services. Some cookies are essential for the operation
